Families Qualifying for Discounted Parish Rate: Grades Pre-Kindergarten - 8

For the second child	\$5,799	10 months at \$579.90 or 12 months at \$483.25	Interest Free
For the third child	\$5,599	10 months at \$559.90 or 12 months at \$466.58	Interest Free
For the fourth child	\$5,399	10 months at \$539.90 or 12 months at \$449.92	Interest Free

To be considered for a parish rate, a family will agree to contribute a minimum of \$780.00 annually to the parish for the coming year. Contributions will be verified in the parish office before the Pastor signs any forms required by the schools for the parish discount.

Registration Fees

Registration Fees for all students PreKindergarten - 8th are \$300 per child (non-refundable). At least one registration fee per family is due at the time of registration.

The balance of registration fees are due by May 16, 2017. Registration fees are required of all students no matter what time of the year they enter the school.

Tuition Payments

Families choosing to pay monthly **MUST** enroll in the FACTS Tuition Management System. Tuition payments will only be received in the office IF families choose to pay tuition in one lump sum, due by August 8, 2017 or by semester payments, due August 8, 2017 and January 17, 2018.

St. Peter School Service Program

SPS has established a policy which states that each school family will provide 30 hours of service to the school over the course of the year. If a school family has not provided all 30 hours of service by May 15, 2018, the family's account will be assessed a \$10 fee for each hour not served. Family participation is an essential component for successful Catholic schools.

Tuition Assistance

Limited funds are available through St. Peter Catholic School and Parish and through the Diocesan Bishop's Scholars Fund to qualifying students who require financial assistance to attend St. Peter the Apostle Catholic School. All families applying for tuition assistance **MUST** fill out the FACTS Grant & Aid Assessment to be considered for tuition assistance.

NOTE: The 2017-2018 Registration Form, Registration Fee of \$300, and Tuition Agreement are due by March 1, 2017, for returning students. After March 1, 2017, the late registration fee for all RETURNING students will be \$350 for each student. If you have paid at least one of the \$300 registration fees for your students by March 1, 2017, the remaining registration fees are not considered late and will still be \$300.
